- This promotion is valid from October 1 - December 31, 2006. Invoice dates for qualifying replacement Cantata Technology products must fall within the promotional period to be eligible for trade-in rebate
- The Cantata trade-in promotion is open to Cantata application partner customers, resellers, and end-user customers worldwide
- This offer is not valid with any other promotional offers and/or special pricing discounts from Cantata Technology.
- Only the purchase of qualifying product(s) is eligible for trade-in of qualifying product(s). Refer to www.cantata.com/futurefax for complete list of eligible products. Rebates are not valid on the purchase of evaluation, used or leased equipment.
- Products eligible for rebate must have been purchased between October 1 – December 31, 2006.
- Rebate credits are calculated based on replaced product. Rebate amount is \$100 per trade-in port for qualifying Cantata fax products and qualifying competitive fax products. Limit of one \$100 per port rebate against each new port purchased, dependent on product traded in.

- Program participant must ship all trade-in equipment to Cantata within 90 days from the date of purchase of new Cantata products to qualify for the rebate. No exceptions will be made.
